#### **Mayor Report**

The mayor explained that section 3149 of the Boone County Zoning Regulations details the parking and storage of certain vehicles in unincorporated Boone County, Florence and Union. To this day, the City of Union has had an exception written into these provisions, which allows these vehicles to be placed in the front yard and, on occasion, a corner side yard, if it is under 25 feet in length. The mayor made the recommendation that it is time we do away with these exceptions due to the increase in issues of late. If the Commission approves, official notice will be given to the Planning Commission concerning the issue. No motion was necessary. The Commission all agreed to send a request to the Boone County Planning Commission to start the process of review.
