MUNICIPAL ORDER 2021-25 - AN ORDER OF THE CITY COMMISSION OF THE CITY OF UNION, KENTUCKY ("CITY"), ENCOURAGING AND INDUCING 9541 US 42 LLC, ITS AFFILIATES, SUCCESSORS AND/OR ASSIGNS (THE "COMPANY"), TO PROCEED WITH THE ACQUISITION, DEVELOPMENT, CONSTRUCTION, AND OPERATION OF A MIXED-USE DEVELOPMENT PROJECT COMPRISING AN "INDUSTRIAL BUILDING" WITHIN THE MEANING OF KRS 103.200, *ET SEQ.* BY AGREEING TO UNDERTAKE THE ISSUANCE OF INDUSTRIAL BUILDING REVENUE BONDS, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$190,000,000, SUBJECT TO ADJUSTMENT, ISSUED IN UP TO THREE SERIES CONSISTING OF AN "A" SERIES IN A MAXIMUM AGGREGATE AMOUNT OF UP TO \$170,000,00 ("A BONDS"), A "B" SERIES AND A "C" SERIES IN A MAXIMUM AGGREGATE AMOUNT OF UP TO \$20,000,000 (THE "SPECIAL OBLIGATION BONDS"); AGREEING TO A MEMORANDUM OF AGREEMENT ("MOA"), A PAYMENT IN LIEU OF TAXES AGREEMENT BETWEEN THE COMPANY AND THE CITY ("PILOT AGREEMENT"), AND A DEVELOPMENT AGREEMENT SUBJECT TO CONTINGENCIES SET FORTH IN THE MOA; AND AGREEING TO TAKE SUCH OTHER ACTION AS NECESSARY OR REQUIRED TO AUTHORIZE THE ISSUANCE OF THE BONDS.
