ORDINANCE NO. 2022-23**

**AN ORDINANCE OF THE CITY OF UNION, KENTUCKY AMENDING CHAPTER 72A
REGARDING THE REGULATION OF PARKING ON THE CITY'S PUBLIC STREETS
WITHIN THE CITY OF UNION, KENTUCKY**

**NOW, THEREFORE, BE IT ORDAINED BY THE UNION CITY COMMISSION AS
FOLLOWS:**

The Union City Commission amends Chapter 72A.030 of the City of Union, Kentucky Code of Ordinances, to read as follows:

CHAPTER 72A

72A.010: PUBLIC STREETS WITH A NO PARKING RESTRICTION

Parking shall be prohibited on the following public streets located within the City of Union, Kentucky:

Appomattox Drive (median lanes)
Arbor Springs Blvd. (median lanes)
Aria Court (one-way)
Bayswater Drive (median lanes)
Braxton Road (commercial portion)
Brillance Avenue
Burleigh Lane (median lanes)
Callie Way
Cavalry Drive
Clarkston Lane (city portion)
Double Eagle
Farmview Drive (city portion)
Farmcrest Drive (city portion)
Hempsteade Drive (median lanes)

72A.020

Parking shall be prohibited within any cul-de sac and on one side only for the following streets within the City of Union, Kentucky:

72A.030: PUBLIC STREETS WITH A SPECIAL PARKING RESTRICTION

Cherbourg Drive -“No Parking between the Signs” along inside of the horizontal curve for a distance of approximately 225 feet fronting 9775 Cherbourg Drive. Parking shall be prohibited in the Cul-De-Sac and on only one side of the street on the remaining portion of Cherbourg Drive.

Braxton Road - Beginning from 6:00 PM until 6:00 AM parking will be restricted to four hours only on the north side of Braxton Road beginning at the intersection of Braxton Road and Richmond Road, continuing east to the border of Union and Florence 430 feet.

Burleigh Lane – No parking for the first 210 feet on the North Side of Burleigh Lane starting at the intersection of Hempsteade Drive going in an Easterly Direction

Arbor Springs Blvd. No parking between the Signs along the inside curve for a distance of 204 feet between 2013 Arbor Springs Blvd and 2031 Arbor Springs Blvd.

Effective Date of Ordinance: This Ordinance shall be effective when read, passed and published according to Law.

This ordinance shall be published in summary pursuant to K.R.S. 83A.060 (9).


