### CITY OF UNION, KENTUCKY ORDINANCE NO. 2024-13

AN ORDINANCE ADOPTING AND APPROVING OF THE GOALS AND OBJECTIVES FOR THE OUR BOONE COUNTY – PLAN 2045 COMPREHENSIVE PLAN AS PART OF THE REVIEW OF THE CURRENT BOONE COUNTY COMPREHENSIVE PLAN APPLICABLE TO THE CITY OF UNION

**WHEREAS**, the City of Union, Kentucky is a member of the Boone County Planning Commission, a county-wide planning unit established pursuant to Chapter 100 of the Kentucky Revised Statutes for Boone County, Kentucky; and

WHEREAS, the Boone County Planning Commission has prepared and recommended for adoption of the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan for Boone County, Kentucky; and

WHEREAS, the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan have been prepared in accordance with the procedural requirements set forth in Chapter 100 of the Kentucky Revised Statutes by the Boone County Planning Commission and recommended for adoption to the City of Union, Kentucky, as well as other legislative bodies and Fiscal Court comprising the membership of the Boone County Planning Commission; and

*WHEREAS*, the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan, as prepared, adopted, and recommended by the Boone County Planning Commission by Resolution R-24-014-A have been reviewed by the City Commission of the City of Union, Kentucky.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF UNION, KENTUCKY AS FOLLOWS:

# **SECTION I**

That the requirements of Chapter 100 of the Kentucky Revised Statutes having been followed, the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan prepared by the Boone County Planning Commission based upon the Our Boone County – Plan 2045 Comprehensive Plan and more particularly described in Boone County Planning Commission R-24-014-A shall be and the same are hereby adopted and approved, by the City of Union, Kentucky, adopted and approved herein, being attached marked as Exhibit "A", and incorporated herein by reference as if fully set out. The text of the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan were prepared by the Boone County Planning Commission and its staff in accordance with the provisions, public hearings, and procedures required by K.R.S. Chapter 100 and are entitled "OUR BOONE COUNTY – PLAN 2045" and further identified as being the subject of a public hearing conducted on April 17, 2024.

#### **SECTION II**

Adoption of the Statement of Goals and Objectives for the Our Boone County - Plan 2045

Comprehensive Plan herein shall have no effect on the current Boone County Subdivision regulations and those Subdivision regulations shall remain in full force and effect.

# **SECTION III**

This Ordinance and the Statement of Goals and Objectives for the Our Boone County – Plan **2045** Comprehensive Plan adopted herein, as applicable to the City of Union, Kentucky, their parts, sections, subsections, clauses and provisions are hereby declared to be servable. If a Court having jurisdiction invalidates any part, section, subsection, clause or provisions of this Ordinance or of the Boone County Zoning regulations adopted herein, including text and map, all other parts, section, subsections, clauses or provisions shall remain valid and effective as they are severable and intended to continue in full force and effect regardless of any invalidity of any other part, section, subsection, clause or provision.

### **SECTION IV**

Publication of this Ordinance and the Statement of Goals and Objectives for the Our Boone County – Plan 2045 Comprehensive Plan adopted herein, thereby making this Ordinance and those regulations effective, is directed to be by summary publication in accordance with Kentucky Law.
